



“Letters to Daddy” Fiscal Sponsorship Confirmation

To whom it may concern:

This letter confirms the following:

Orange County NY Arts Council, Inc. is a New York not-for-profit corporation organized on February 5, 2007. The Council was issued its 501(c)(3) determination letter by the Internal Revenue Service on March 24, 2008. As of this date the Council is in good standing as a New York not-for-profit corporation and maintains its 501(c)(3) status. The Employer Identification number of the Council is 20-8470131. The New York Attorney General's Charities Bureau identification number of the Council is 40-75-70. Copies of the Arts Council's 501(c)(3) paperwork will be made available upon request.

4e Productions, LLC, is a Connecticut limited liability company that intends to create and produce, as an educational, charitable project, up to 75 live theatrical performances of the musical show “Letters to Daddy” in K-12 schools in and around Orange County (the “Project”).

The Council entered into a written agreement with 4e dated June 2, 2011, in which the Council agreed to serve as fiscal sponsor for 4e for the Project. The Council simultaneously entered into a written agreement with a professional fund raiser for the Project chosen by 4e, Aman Business Transitions, LLC. These agreements are available for review upon request.

As fiscal sponsor, the Council will accept gifts, contributions and grants for the benefit of the Project and furnish the donor with a receipt from the Council which the donor may use to claim a charitable tax deduction to the extent allowed by law. The Council will use the funds contributed to defray the costs of the Project. The Council is entitled to deduct from contributed funds an administrative fee for its services. If the funds contributed exceed the costs of the Project, the excess may be retained by the Council and applied in furtherance of its corporate purposes. The Council has no obligation to raise funds or guarantee the accomplishment of the Project.
